Sub. : Surprise Inspection of affiliated Colleges for grant of Continuation

/ Extension of Affiliation for Academic Year 2022-23...

Ref.: University Direction No. 02/2016 dated 13/12/2016,

It is notified to all concerned that University has initiated with process of Continuation of Affiliation/ Extension of Affiliation (if applicable) of affiliated Colleges for Academic Year 2022-23. Accordingly, the University has finalised Local Inquiry Committee (LIC) proforma (Part-I: Inspection Format & Part-II: College Information) for inspections, which is attached herewith for information & necessary action.

The Colleges are required to go through Revised LIC's Inspection Proforma and shall fill-up requisite information including all Annexures for verification of LIC Team. It is also mandatory for Colleges to upload College Information (Part-II) and Annexure I-A, I-B, II, III, IV, V & VI on College website. The College is required to create "MUHS Mandate" tab on College website homepage and under it Academic Year-wise College Information details and all Annexure-wise information must be uploaded. It is mandatory for the Colleges to keep Year-wise College Information alongwith all Annexure's on College website and it shall not be removed from College website for a period of 05 years.

University has taken up paperless initiative and as such the College is required to submit hard copies of Annexures I-A, I-B, II, III, IV & VII only to the University. Other Annexure's copies are not required to be submitted to the University.

It is mandatory for the College to maintain infrastructure, teaching staff and other requirements as per MSR throughout year; failing which affiliation granted shall be revoked by the University at any stage.

The Dean/Principal of the College is required to update College website with revised proforma as well as keep information ready for verification of the LIC Team, which shall be started by the University from 15/05/2022 onwards. It is clarified that the Colleges, who fails to update their information on College website, will not be granted affiliation.
